IMPORTANT DATES

- August 6, 2025 - Secretary of State issues Proclamation calling for Election. All potential candidates must be registered to vote prior to this date to be eligible for election.
- August 26, 2025 - Candidate Filing Day between the hours of 9:00 a.m. and 5:00 p.m. in the County Clerk's Office.
- August 29, 2025 - County Clerk's must notify Candidates of their qualification and position on ballot.
- September 2, 2025 - Filing Day for Write-In Candidates
- September 2, 2025 - Last Day for a Candidate to withdraw from the Election
- October 7, 2025 - Absentee & Early Voting begins
- November 1, 2025 - Absentee & Early Voting ends
- November 4, 2025 - Election Day
- November 10, 2025 - Board of County Commissioners Certify Election Results
